While at Bederson, Tim was appointed to serve as Special Master in a Federal District Court Case; State Court Trustee and State Court Receiver. Tim was selected to serve on a committee with Judge Moore and the U.S. Trustee to evaluate the role of Examiner in the District of New Jersey. Tim also served as a duly appointed Chapter 11 Trustee. He was selected as post-confirmation liquidating Trustee on numerous occasions and has assisted Trustees and other Fiduciaries in liquidations.

He has been a featured speaker for organizations including: Bankruptcy Bench Bar Conference; NJ panel of Bankruptcy Trustees; NY Institute of Credit; NJCPA; AGN and IWIRC.

Tim serves as Treasurer of the West Orange Lions Club and is also its Past President.
